INTRODUCTION

Families Australia is pleased to present its Annual Report for 2006-07. This is our sixth Annual Report.

The Report comprises: information about Families Australia; a report by the Chair; information about the Board; a report by the Executive Officer, a listing of Members as at 30 June 2007; a report on Families Australia's performance during 2006-07 in relation to the goals contained in the Strategic and Business Plans; and the financial and auditor's reports.

It is hoped that this Report will assist readers to understand and evaluate Families Australia's work, and stimulate feedback about ways in which our work can further be improved.

ABOUT FAMILIES AUSTRALIA

Established in 2001, Families Australia is the national independent, peak, not-for-profit organisation dedicated to promoting the needs and interests of families. Families Australia is funded in part by members and in part by the Australian Government Department of Families, Community Services and Indigenous Affairs.

Families Australia strives to represent the interests of families in Australia, working from a network of services, organisations, carers, consumers and communities, which takes in a rich diversity of families and communities.

Families Australia envisions a society that recognises the central role of families in our community and embraces its responsibilities for the development, nurturing and wellbeing of all families in Australia.

Specifically, Families Australia:

- provides policy advice to government on behalf of families;
- informs its members and the community about directions in national family policy, services and research; and
- actively promotes and celebrates the importance of families, including through National Families Week.

Families Australia has:

- a diverse membership base of 387 family and community sector organisations across Australia (with a combined estimated 150,000 workers), including 33 General Members, many of which are peak organisations in their own right. As well as national bodies, Families Australia also represents many local and regional community service organisations such as child care centres and youth services;
- mobilised around 400,000 people across Australia to celebrate the vital importance of families during National Families Week in May since 2003;
- raised national awareness of family issues such as child abuse and neglect, work and family, grandparenting, the impact of substance abuse on families, and family wellbeing through direct representations to Parliamentary Committees, Ministers and other Members of Parliament;
- hosted national conferences such as the 2007 National Family Wellbeing Symposium, the 2006 Work, Family and Wellbeing Forum, the 2004 Globalisation, Work and Family Conference and the 2004 National Child Abuse and Neglect Summit;
- advanced the views of families and family sector organisations to a wide range of Federal government agencies such as the Department of Families, Community Services and Indigenous Affairs, the Australian Bureau of Statistics, the Australian Taxation Office, Centrelink, the Child Support Agency and Medicare;
- taken leadership in developing Australia's first national child protection strategy by participating actively in the National Child Protection Forum (2006), through involvement in planning and by providing the Chair for the

Forum. The Forum brought together leading political, government and community representatives;

- provided information to family and community sector organisations about latest developments in national family policy, practice and research through the Families Australia magazine *Family*, *National Family News* and the Families Australia website (www.familiesaustralia.org.au); and
- informed government and the family and community sector about the issues facing families by running focus groups for members of the public across Australia.

The Board comprises up to 13 members, who bring expertise in family policy, practice and research, as well as extensive networks within the community, private and public sectors and society more broadly. Families Australia is served by a Secretariat based in Canberra.

CHAIR'S REPORT

In our sixth year of operation, Families Australia built on the firm foundations of the previous six years and made further strong gains in promoting the needs and interests of Australian families.

Despite an increase in single person households, 87% of us continue to live in family households. Of the 5.5 million families in Australia, 60% include children – 79% with dependent children and 21% with non-dependent children (ABS 2003). What happens to families remains a critical issue for the wellbeing of the Australian society.

This Annual Report highlights the many achievements of Families Australia over the past year. We continue to “punch above our weight” in terms of output and our contribution to policy development and key networks.



EXECUTIVE OFFICER'S REPORT

Families Australia's primary role is to nurture a national policy environment which enhances the wellbeing of all Australian families. We strive to do that by working with families themselves, Families Australia's members, the Federal Government and its agencies, members of Parliament and the media.

2006-07 was a year of strong achievement and growth for Families Australia. We developed and promoted policy on more fronts than ever before.

A particular success was the National Family Wellbeing Symposium, the first such gathering of its kind to explore the meaning and measurement of family wellbeing. Families Australia obtained considerable public and political attention for its calls, including for the development of a National Family Wellbeing Framework and a comprehensive national State of the Family report.

We continued to take a national leadership position in relation to child protection through our facilitation of efforts to devise a National Child Protection Strategy which could inform intergovernmental considerations. We will continue to advance this matter with vigour.

Families Australia also made substantial headway in other policy areas. Our work on the challenges facing grandparents proved timely and of considerable political and public interest. Families Australia's policy work on substance abuse generated substantial interest with several of our propositions being reflected in the Report of the House of Representatives Standing Committee on Family and Human Services on the impact of illicit drugs on families. All these policy outcomes were contained in a new 'Family Policy Series', available on Families Australia's website.

Families Australia also advanced policy positions on issues such as the Federal Government's Northern Territory 'emergency measures', the proposed National Access Card and the Federal Government's welfare payment diversion proposal. We highlighted Indigenous family issues through coverage in our publications and through our representation on the Australian Council for Children and Parenting. We gave greater emphasis to issues facing people with disabilities, in particular by participation on the Australian Government's Carer Payment (Child) Review Taskforce.

National Families Week, which was held between 13 and 19 May 2007, set new records, with over 110,000 people participating in more than 1,000 community events around the country which were run by 750 organisations and their subsidiaries. National Families Week 2007 was given a particular boost by the appointment of 24 high profile Ambassadors who promoted this year's message of 'Families Investing in Time Together'.

We assisted Families Australia members in a variety of ways. Our publications provided up-to-date information about national developments in family policy, practice and research, including funding opportunities. We provided advice

and practical assistance to members about promoting their views to, and working with, government.

We gave even greater emphasis to consultation to inform our policy work. Several public focus groups were conducted in both urban and rural areas. Families Australia members were surveyed to obtain their views about family issues and possible policy solutions. The information obtained from these consultations was used in our ongoing discussions with Government, in submissions to Parliamentary inquiries and in Families Australia's representation roles on consultative committees run by government departments and agencies, such as Centrelink, Medicare, the Australian Taxation Office and the Australian Bureau of Statistics.

We undertook a major project to assist people who were in institutional care as children (the "Forgotten Australians"). This has been very rewarding, and we learn from these survivors as we support them in promoting their interests.

Families Australia's growth has derived from the dedication and energy of many individuals and organisations, as well as the valued support of the Australian Government and the Australian Government Department of Families, Community Services and Indigenous Affairs.

I wish to thank the Board for their unstinting support throughout the year and my fellow staff members – Jennifer Horsfield, Eris Harrison, Grace Concannon and Jerry Feng – for their outstanding work. I wish also to thank the Families Australia members for their participation across a range of activities through the year, such as National Families Week and in the development of policy positions.

The year ahead will see Families Australia do more to promote the interests of families at the national level. We will add to the range of policy subjects we advance and increase the flow of information to members and the public about national family policies, practice and research. We will strive further to expand and diversify the organisation's financial base as well as seek to increase the number of members and the quality of services we provide to them.

We would welcome suggestions and ideas about ways we can do our job more effectively in the interest of all Australian families.

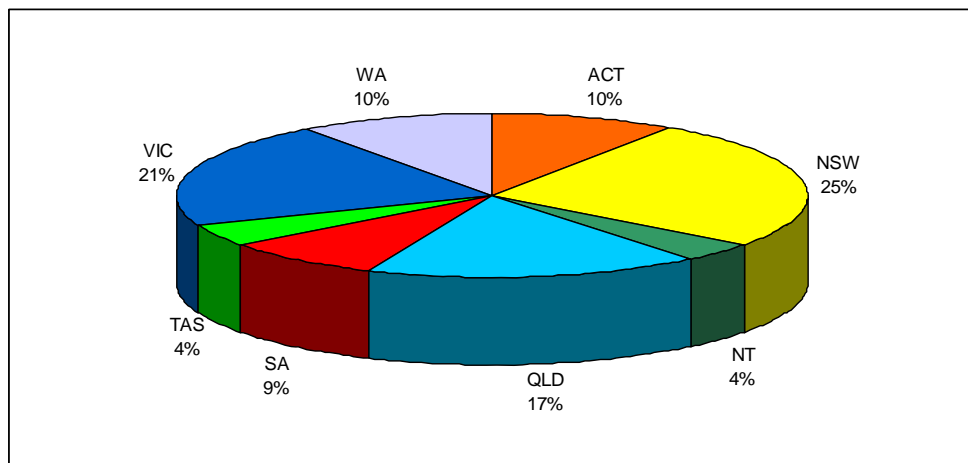

GOALS AND PERFORMANCE

Families Australia's Strategic Plan (2005-07) contains four goals:

1. Inform and influence national policies in relation to families.
2. Promote the importance and needs of families.
3. Act as a two-way conduit for information to and from the family sector.
4. Strengthen and expand the organisation.

The 2006-07 Business Plan lists activities undertaken to achieve these goals. The following report provides information on Families Australia's performance in relation to the four goals and the associated Business Plan activities.

1. Inform and influence national policies in relation to families

Families Australia advanced this objective by:

- Convening the National Family Wellbeing Symposium at The Australian National University, Canberra, in June 2007. The Symposium involved high-level representatives from the Australian Government, community, research and other sectors, as well as speakers from overseas and international organisations such as UNICEF, the Organisation for Economic Cooperation and Development, Child Trends USA and the New Zealand Families Commission. The Australian Government Minister for Families, Community Services and Indigenous Affairs, the Hon. Mal Brough MP, opened the Symposium. The Federal Shadow Minister for Family and Community Services and for Indigenous Affairs and Reconciliation, Ms Jenny Macklin MP, also addressed the Symposium.

The first such gathering of its type, the Symposium explored the meaning and measurement of family wellbeing and concluded that work should proceed to develop a family wellbeing framework, with the aim of providing a comprehensive model which may assist decisions about family-related policy, practice and research. A family wellbeing framework could also provide the basis for a future report on the state of family wellbeing in Australia. A large number of Families Australia member organisations participated in the Symposium.

- Highlighting grandparenting issues through the release of a Family Issues Series report entitled 'Grandparenting: Present and Future' (January 2007). The report, which contained 29 policy and practice recommendations, was disseminated widely, including to all Families Australia Members, Federal MPs/Senators, selected State/Territory Ministers and Departments. It received extensive political, public and media attention. Many Families Australia member organisations were involved in the consultations which were conducted to prepare the final policy position. Families Australia briefed Parliamentarians and, in May 2007, the Australian Senate carried a motion commending Families

Australia for its work on grandparenting and urging government to do more for grandparents.

- Focusing Parliamentary and public attention on the impact of substance abuse on families. Families Australia presented a major written report and oral evidence to the House of Representatives Standing Committee on Family and Human Services on the effects of illicit drugs on families. The report and submission were based on in-house research and consultations with numerous community and government organisations, focus groups for family members and professionals and an expert forum involving national level professionals in Canberra, including many Families Australia member organisations. The submission contained 11 policy and service delivery recommendations and received extensive media coverage.
- Leading the working party comprising Australian and State government, research and community sector representatives, which prepared and submitted to the Australian Government Department of Families, Community Services and Indigenous Affairs the draft National Child Protection Strategy. This work arose from the National Child Protection Conference in June 2006, which Families Australia's Chief Executive Officer chaired at the request of the Australian Government.
- Commenting on a wide range of family-related issues in various government and community forums and initiatives. These included: the Australian Government's Carer Payment (Child) Review Taskforce, the Australian Council for Children and Parenting (Families Australia's Chief Executive Officer was the Deputy Chair), the Carers Australia-Department of Health and Ageing symposium which examined ways to improve the health of carers, the ACT 'Communities for Children' community-business symposium, the ALP Family Watch Committee, the Federal Parliamentary Backbench Committee on Family and Community Services, the 'Federal Parliamentarians Against Child Abuse', Australian Government Department of Families, Community Services and Indigenous Affairs' Family Expo in Melbourne and Canberra and the National Leadership Group for White Ribbon Day to raise awareness about violence toward women and children. We also communicated with a diverse range of Federal Parliamentarians.
- Engaging with Ministers, Ministerial advisers and with senior officials of the Australian Government Department of Employment and Workplace Relations, and the Australian Government Department of Families, Community Services and Indigenous Affairs on issues such as mental health, child protection, the proposed National Access Card and the implications of changes to workplace relations laws.
- Providing a detailed formal response to the Australian Government's November 2006 proposal to divert cash welfare payments to non-cash benefits. The position paper was based on a survey of views of Families Australia members.

- Highlighting through Families Australia's publications and policy statements the importance of Indigenous child protection issues.
- Representing family interests in a wide range of Australian Government consultative forums, in particular: the Centrelink Community Participation Reference Group, the Medicare Consumer Consultative Group, the Child Support Agency, the Australian Taxation Office Personal Tax Advisory Group and the Australian Bureau of Statistics' Family Statistics Advisory Group.

2. Promote the importance and needs of families

Families Australia advanced this objective by:

- Obtaining a record level of participation in National Families Week 2007. Over 110,000 people participated in 1,000 events which were run by 750 organisations and their subsidiaries. In 2006, 105,000 people participated in 550 events run by 389 organisations. Extensive media coverage was obtained and feedback from participating organisations was very positive. Twenty-four high profile National Families Week Ambassadors, including Senior Australian of the Year, Phil Herreen, Young Australian of the Year, Tania Major, and youth advocate Barbara Holborrow OAM, promoted the theme of 'FITT Families - Families Investing in Time Together'.
- Raising public awareness about important family issues through numerous radio, television and print media interviews on issues such as grandparenting, family wellbeing, substance abuse, child protection, work and family, ageing, parenting and family resilience. Families Australia's comments were carried at various times in most major metropolitan, regional and rural media services. Families Australia's Chief Executive Officer also undertook many public speaking engagements through the year.
- Auspicing the Alliance for Forgotten Australians (AFA), a group drawn from the estimated 500,000 persons who were in institutional or out-of-home care in Australia between the 1930s-1970s and who were the subject of a 2004 Australian Senate report. Consequent to an Australian Government funded conference for the 'Forgotten Australians' in May 2006, AFA was established with a Steering Committee and advisory group. Families Australia entered into an agreement with the Australian Government Department of Families, Community Services and Indigenous Affairs to auspice AFA and to manage project funding to assist this group. The funds will be used to assist the Alliance to establish itself and for the preparation of resources, including a website and information booklet, concerning the particular needs of this group.

3. Act as a two-way conduit for information to and from the family sector

Families Australia advanced this objective by:

- Seeking the views of Families Australia Members and other key stakeholders through numerous meetings, conferences and members' forums (such as the Brisbane members' forum in August 2006).
- Running focus groups with members of the public on issues such as family wellbeing, grandparenting, substance abuse, quality standards in child care and the challenges facing the not-for-profit sector. Focus groups were often arranged by Families Australia member organisations and were held in a range of locations such as Melbourne, Brisbane, Sydney, Dubbo, Wollongong, Queanbeyan, Canberra and Ballarat.
- Publishing and disseminating to Families Australia members and other key stakeholders, including Federal politicians and public servants, Families Australia's magazine *Family* and the monthly *National Family News*, which contains latest information about national family policy, practice and research.
- Upgrading and re-launching Families Australia's website, which increased the quality and accessibility of information to members and the public. Free resources which were made available to members included a methodology paper on running focus groups and a paper on preparing a risk assessment framework for not-for-profit organisations.

4. Strengthen and expand the organisation

Families Australia advanced this objective by:

- Increasing revenues by: running the National Family Wellbeing Symposium at a financial surplus and obtaining sponsorship from the Australian Government Department of Families, Community Services and Indigenous Affairs and The Australian National University; auspicing the Alliance for Forgotten Australians; and acting as the managing agent for a project in conjunction with Axis Development, an ACT-based not-for-profit community sector training organisation, to provide training materials to the NSW Government Department of Disability, Ageing and Home Care.
- Successfully obtaining additional members through a mail-out campaign; this resulted in an increase in memberships from 359 on 1 July 2006 to 387 as at 30 June 2007.
- Ensuring that governance and management oversight remained at the highest possible professional standard through mechanisms such as detailed reports to every Board meeting on performance in relation to annual business plan and budget targets, monthly performance reports to the Board and the provision to the Board of a detailed annual risk assessment.
- Meeting all reporting and performance obligations to the Australian Government Department of Families, Community Services and Indigenous

Affairs in relation to the National Secretariat Program and National Families Week contracts.

- Undertaking a campaign to obtain corporate sponsorship for National Families Week 2007 and advancing an application for tax deductible status.
- Obtaining an unqualified external financial audit report in relation to the 2006-07 accounts, and taking action on all recommendations for minor enhancements arising from the 2005-06 audit.
- Further strengthening management systems, including through upgrading of information and communication systems and security, and staff training and development, including in the areas of accounting and website maintenance.
- Establishing and extending Families Australia's connections with similar overseas organisations, including the Asia-Pacific Families Network, the New Zealand Families Commission, the UN Focal Point on Families in New York, the UNICEF Innocenti Research Centre, Florence, Italy, the Social and Economic Division of the Organisation for Economic Cooperation and Development, Paris, and Child Trends, Washington, USA.



NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

The financial report is a general purpose financial report that has been prepared in accordance with Accounting Standards, Urgent Issues Group Interpretations, other authoritative pronouncements of the Australian Accounting Standards Board and the requirements of the *Associations Incorporation Act (ACT) 1991* of the Australian Capital Territory.

The financial report covers Families Australia Incorporated as an individual entity incorporated in the Australian Capital Territory under the *Associations Incorporation Act (ACT) 1991*.

The financial report of Families Australia Incorporated as an individual entity complies with all Australian equivalents to International Financial Reporting Standards (AIFRS) in their entirety.

The following is a summary of the material accounting policies adopted by the association in the preparation of the financial report. The accounting policies have been consistently applied, unless otherwise stated.

Reporting Basis and Conventions

The financial report has been prepared on an accruals basis and is based on historical costs modified by the revaluation of selected non-current assets, and financial assets and financial liabilities for which the fair value basis of accounting has been applied.

Accounting Policies

a. Income Tax

No provision for income Tax has been raised, as the association is exempt from income Tax under Division 50 of the income Tax assessment ACT 1997.

b. Property, Plant and Equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation and impairment losses.

Plant and equipment

Plant and equipment are measured on the cost basis less depreciation and impairment losses.

The carrying amount of plant and equipment is reviewed annually by the association to ensure it is not in excess of the recoverable amount from those assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the assets' employment and subsequent disposal. The expected net cash flows have been discounted to their present values in determining recoverable amounts.

The cost of fixed assets constructed within the association includes the cost of materials, direct labour, borrowing costs and an appropriate proportion of fixed and variable overheads.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the association and the cost of the item can be measured reliably. All other repairs and maintenance are charged to the income statement during the financial period in which they are incurred.

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

Depreciation

The depreciable amount of all fixed assets including building and capitalised lease assets, is depreciated over the useful lives of the assets to the Association commencing from the time the asset was held ready for use.

The depreciation rates used for each class of depreciable assets are:

Class of Fixed Asset	Depreciation Rate	Depreciation Basis

The assets' residual values and useful lives are reviewed and adjusted, if appropriate, at each balance date.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains and losses are included in the income statement. When revalued assets are sold, amounts included in the revaluation relating to that asset are transferred to retained earnings.

c. Financial Instruments

Recognition

Financial instruments are initially measured at cost on trade date, which includes transaction costs, when the related contractual rights or obligations exist. Subsequent to initial recognition these instruments are measured as set out below:

Financial assets at fair value through profit and loss

A financial asset is classified in this category if acquired principally for the purpose of selling in the short-term or if so designated by management. Derivatives are also categorised as held for trading unless they are designated as hedges. Realised and unrealised gains and losses arising from changes in the fair value of these assets are included in the income statement in the period in which they arise.

Available-for-sale financial assets

Available-for-sale financial assets include any financial assets not included in the above categories. Available-for-sale financial assets are reflected at fair value. Unrealised gains and losses arising from changes in fair value are taken directly to equity.

Financial liabilities

Non-derivative financial liabilities are recognised at amortised cost, comprising original debt less principal payments and amortisation.

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

Impairment

At each reporting date, the association assess whether there is objective evidence that a financial instrument has been impaired. In the case of available-for-sale financial instruments, a prolonged decline in the value of the instrument is considered to determine whether impairment has arisen. Impairment losses are recognised in the income statement.

d. Impairment of Assets

At each reporting date, the association reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value-in-use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the income statement.

Where it is not possible to estimate the recoverable amount of an individual asset, the association estimates the recoverable amount of the cash-generating unit to which the asset belongs.

e. Employee Benefits

Provision is made for the association's liability for employee benefits arising from services rendered by employees to balance date. Employee benefits that are expected to be settled within one year have been measured at the amounts expected to be paid when the liability is settled, plus related on-costs. Employee benefits payable later than one year have been measured at the present value of the estimated future cash outflows to be made for those benefits.

f. Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities on the balance sheet.

g. Revenue

Revenue from the sale of goods is recognised upon the delivery of goods to customers.

Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets.

Dividend revenue is recognised when the right to receive a dividend has been established.

All revenue is stated net of the amount of goods and services tax (GST).

h. Government Grants

Income is recognised when the entity obtains control of the contribution or the right to receive the contribution. It is probable that the economic benefits comprising the contribution will flow to the entity and the amount of the contribution can be measured reliably.

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

i. Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Tax Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the balance sheet are shown inclusive of GST.

Cash flows are presented in the cash flow statement on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows.

j. Comparative Figures

When required by Accounting Standards, comparative figures have been adjusted to conform to changes in presentation for the current financial year.

k. Leases

Leases of fixed assets, where substantially all the risks and benefits incidental to the ownership of the asset, but not the legal ownership, are transferred to the Association are classified as finance leases. Finance leases are capitalised, recording an asset and a liability equal to the present value of the minimum lease payments, including any guaranteed residual values. Leased assets are depreciated on a straight line basis over their estimated useful lives where it is likely that the Association will obtain ownership of the asset, or over the term of the lease. Lease payments are allocated between the reduction of the lease liability and the lease interest expense for the period.

Lease payments for operating leases, where substantially all the risks and benefits remain with the lessor, are charged as expenses in the periods in which they are incurred.

Lease incentives received under operating leases are recognised as a liability. Lease payments received reduced the liability.

l. Critical Accounting Estimates and Judgments

The committee members evaluate estimates and judgments incorporated into the financial report based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the association.

Key Estimates — Impairment

The association assesses impairment at each reporting date by evaluating conditions specific to the group that may lead to impairment of assets. Where an impairment trigger exists, the recoverable amount of the asset is determined. Value-in-use calculations performed in assessing recoverable amounts incorporate a number of key estimates.

Key Judgments — Doubtful Debts Provision

The committee members believe that no amounts due from memberships from associate and general members will not be recoverable as at 30 June 2007.


