21 June: This Report is based on the Human Rights and Equal Opportunity Commission's 2006 National Inquiry into discrimination against people in same-sex relationships in the area of financial and work-related entitlements. The Inquiry held public hearings and community forums around Australia and received 680 submissions covering a range of topics, many of which described the impact of discriminatory laws on same-sex couples and their children. 30 May: This is the third national statistical report to be compiled by the Australian Institute of Health and Welfare on the health and wellbeing of young people aged 12-24. Educational outcomes of children on guardianship or custody orders: a pilot study

14 June: This Australian Institute for Health and Welfare report provides a snapshot of the academic performance, as assessed by literacy and numeracy test scores, of children on guardianship or custody orders in 2003. The educational performance of these children is compared with all children sitting these tests, and differences in academic performance between particular subgroups of children on guardianship/custody orders are also examined. This pilot project involved interdepartmental linkage (education and community services departments) of administrative data across multiple jurisdictions - the first Australian study in this field to have done so.
