### **In Home Care draft standards**

7 September: In Home Care (IHC) is a flexible form of child care where approved carers provide care in the child's home. IHC is targeted to families unable to access existing child care services, such as families working shift or non standard hours or those located in rural or remote regions of Australia. The Australian Government Department of Families, Community Services and Indigenous Affairs has developed draft standards to ensure care is focused on quality outcomes for children and relationships between carers, children and their families. ### **Long Day Care Capital Funding Program**

17 September: The Australian Government has committed \$3 million over three years to assist eligible Long Day Care (LDC) operators to expand their existing facilities. This funding is targeted to existing, eligible LDC services that require upgrades or expansion of existing facilities and infrastructure in order to meet additional demand for child care
